

## The Rob Wildeboer Scholarships 2025

#### **Terms and Conditions**

The aim of the scholarships are for the Goodwood Flying School to offer flight training to those who would otherwise not be in a position to learn through monies donated to The Rob Wildeboer Scholarship fund. All scholarships are to be completed at the Goodwood Flying School.

# The scholarships

- 2 x 10 hours towards PPL/LAPL/FI training either for someone partially trained or commencing training in our Cessna 172s.
- I x 5 hours towards PPL/LAPL/FI or tailwheel differences training either for someone partially trained or commencing training in our Piper Cub.

#### What is included

Flight training as specified above. 2025 membership for the Goodwood Aeroclub. Required training literature with thanks to Pooleys Flight Equipment. Reduced ground exam rate where applicable.

#### What isn't included

The required medical.

Licence for any qualification.

Travel costs associated with getting to and from Goodwood and/or any accommodation costs.

## **Pre-entry requirements**

- Candidates must be at least 16 years of age.
- Some flying experience is preferred but not essential.
- Candidates must have obtained, or be in a position to obtain in advance of commencing training, a Class 2 or LAPL medical as appropriate
- You must have the ability to undertake the scholarship during 2025 at Goodwood Aerodrome.

## **Application process**

All candidates should be aware that, if called for interview, they must make their own arrangements to attend the interview.

The stages of the selection process are:

- a. Applications from candidates for each scholarship are open until 28 February 2025 for a scholarship programme in 2025. Applications are to be emailed to <a href="mailto:scholarship@goodwood.com">scholarship@goodwood.com</a>. Candidates are required to complete an application form and explain in no more than 500 words how they would benefit from a scholarship and why they are best suited to receive the scholarship. All applications received will be acknowledged by email. Please advise your approximate location in the application.
- b. Candidates will be assessed by our scholarship panel and invited to an interview. Interviews will be held at the Goodwood Aerodrome during March 2025.
- c. Successful candidates will be offered a place which will be subject to confirmation once all of the eligibility criteria have been satisfied.

  All communications and notifications will be sent to you by email unless you notify us otherwise.

# **Training**

If you are offered a scholarship our Flying School Operations Manager will work with you to arrange suitable dates for your flying training.

If you are selected for a scholarship, you must satisfy yourself that you are able and willing to undergo flying training to the determined standard at the point you are offered the scholarship, if you have any concerns or doubts they must be raised with us immediately.

Prior to commencing training, you must discuss with us if there has been any deterioration in your health. Such matters will always be treated confidentially.

Given that the weather limits the availability of flying time, and that we have to manage the flight training diaries, it is important that you have a good degree of flexibility to allow us to schedule your flying training. All lessons must be booked through the operations desk at the Goodwood Aerodrome and must be booked in 2025.

You must read the Goodwood Flying School operations manual prior to commencing flight training with us and you will be asked to complete and sign a form to confirm that you have read and understood the manual. You will be expected to adhere to the manual at all times whilst undergoing your flying training.

Our Chief Flying Instructor will be available to give you guidance and assistance before and during your flying training.

We will monitor your training throughout your scholarship programme which will include contact with you and we would like you to keep in touch with us throughout.

Flight training inevitably includes risk. It is important that you recognise, understand and accept the risks. It is imperative that you avoid taking any unnecessary risk throughout your flying training including not flying if you feel unwell or tired. You should discuss any matter or concern with the Chief Flying Instructor.

If you have any concerns or problems during your flying training, they should be discussed in the first instance with the Chief Flying Instructor. If they are not resolved then they should be raised with our Head of Aviation.

We encourage you to make use of social media to share your experience as you progress through your scholarship. We would ask that you are sensitive in choosing what you post being particularly careful not to publish anything which may damage or bring into disrepute the public reputation, name or image of Goodwood.

If you are a selected for a scholarship programme you may be requested to take part in promotional activities and that your personal data, and, photographs and images of you may be used in any publicity by us. In accepting the scholarship, you are agreeing to the use of your personal data and images for such purposes. If you are under the age of 18, we may require that your parent / legal guardian sign a declaration of eligibility and liability/publicity release.

If for whatever reason you cannot complete your hours by 31 December 2025 any remaining hours must be used by 31 March 2026. Please discuss this with our Chief Flying Instructor in the first instance.

Once you have completed your scholarship you will be invited to attend an end of season awards evening at the aerodrome and you may be asked to say a few words about your flight training journey.

#### **Data protection**

In accordance with the Data Protection Act 2018, each company in the Goodwood group (The Goodwood Estate Company Limited and each of its subsidiaries) (the 'Company') is registered with the United Kingdom's Information Commissioner's Office as a data controller to collect information. We will collect your information for the purposes of managing your scholarship application and flight training. Such communications will be provided to members by email, post or by telephone. In these terms and conditions where we refer to 'us' or 'we' this means Goodwood and where we refer to 'you' this means the candidate or scholar.

The aim of the scholarship programme is to assist the successful individual, who might otherwise not have the necessary resources to have the opportunity to fly.

We will ensure that the process for selection of candidates is thorough, fair and in accordance with all applicable laws.

There is no obligation to accept any scholarship. The decision to undergo flying training offered or to withdraw from training is yours.

Goodwood reserves the right to withdraw or alter a scholarship programme at any time for exceptional and reasonable commercial reasons.
