

## **Terms and Conditions applicable to the #MastercardHotLaps Competition**

The terms and conditions set out in Section One apply to all of the competitions operated by the Goodwood Road Racing Company Limited ("Goodwood"), whose registered office is at Goodwood, Chichester, West Sussex PO18 0PX, company number 466176. You can contact Goodwood at this address. Additional Terms and Conditions for each individual competition are included in Section Two. The terms and conditions set out in Section One and Section Two are referred to as the "Rules" and this competition will be simply referred to as the "Competition" throughout the rest of these Rules. In these rules, "we," "our," and "us" refer to Goodwood and "you" and "yourself" refers to an eligible Competition entrant.

### **Section One**

#### **1. Who is promoting/sponsoring this Competition?**

The promoter of this Competition is Goodwood. The sponsor of this Competition is Mastercard Europe Services Limited.

#### **2. Can I enter?**

You are eligible to enter this Competition if you meet the following requirements:

- You are 18 years or older at the time of entry, and
- You are not an employee or immediate family of an employee of any of the companies in the Goodwood Group;
- You are not involved in any part of the administration and execution of this Competition; and
- You are not a professional e-sports video gamer.

#### **3. Rules about entry**

There is no purchase necessary to enter this Competition.

Participants may make multiple entries during the Open Qualification.

Competition entries must be made in the manner and during the period specified in Section Two. Failure to do so will disqualify the entry. We reserve the right to disqualify any entrant if we have reasonable grounds to believe the entrant has breached any of these Rules.

#### **4. How are winners selected and notified?**

##### **Open Qualification:**

The fastest fifty (50) hot lap entries submitted in the Open Qualification will progress to the next stage of the Competition, the Heats Phase. The fastest entries will be seeded based on final ranking and this will be used to form the heat groups for the Heat Phase. If your fastest entry qualifies, we will notify you by sending a message to your social media account used at time of entry within 24 hours from the end of the Open Qualification Hours. You must respond to the message within 24 hours and confirm your participation in the Heats Phase.

##### **Heat Phase:**

If your Heats Phase race time qualifies, we will notify you by sending a message to your social media account used at time of entry within 48 hours from the end of last race in the Heat Phase. You must acknowledge receipt of message within 24 hours and liaise with Goodwood's social media team to confirm participation in the Final.

##### **Final:**

If you are the winner we will notify you immediately if you have won, this will be shown on screen in the game. Alternatively, we will contact the winner within 4 hours of the final race concluding should race adjudication have deemed there was any activity to contradict the initial race verdict.

If you are a potential winner, we may require you to sign a declaration of eligibility and liability/publicity release before the prize can be fulfilled. If you do not sign and return these required forms within the time period stated on the winner notification message, we may disqualify you and select an alternative winner.

#### **5. What other conditions am I agreeing to by entering this Competition?**

By entering this Competition, you agree:

- to abide by the Rules;
- to the extent allowable under applicable law, to release and hold harmless Goodwood and its respective advertising and promotional agencies and Competition judging organization, the parent companies, subsidiaries, affiliates, employees, representatives, successors, assigns and agents from any and all liability or any injury, loss, damage of any kind or disappointment arising from or in connection with this Competition or any prize won save with respect to claims resulting from death or personal injury arising from Goodwood's negligence and with respect to claims resulting from fraud or any other liabilities that may not be excluded by law;
- that our decisions will be final and binding on all matters related to this Competition;
- that by accepting a prize, we may use your personal data and image online and in print, or in any other media, in connection with this Competition, without payment or compensation to you. The declaration of eligibility and liability/publicity release provided to the potential winner will make reference to obtaining your free consent to use your personal data;
- that by submitting an entry to this Competition you agree that we shall have a perpetual, royalty free, sub-licensable and worldwide license to use the entry content and material submitted in whole or in part in any format and for any purpose whatsoever, including (but not limited to) promotional and advertising activity and social media channels;
- that you may be requested to take part in promotional activity and that your personal data, photographs and audio and/or visual recordings or interviews of you may be requested and used in any publicity.

#### **6. What laws govern the way this Competition is executed and administered?**

In the event of any dispute regarding the Terms and Conditions, Rules, conduct, results and all other matters relating to this Competition, the decision of Goodwood shall be final and no correspondence or discussion shall be entered into. These Terms and Conditions, the conduct of this Competition and the interpretation and enforcement of these Terms and Conditions shall be governed and construed in accordance with the law of England and Wales. The provisions of the Contracts (Rights of Third Parties) Act 1999 shall not apply to this agreement.

#### **7. What if something unexpected happens and the Competition can't run as planned?**

If cheating, a virus, bug, catastrophic event, or any other unforeseen or unexpected event that cannot be reasonably anticipated or controlled, (also referred to as force majeure) affects the fairness and /or integrity of this Competition, we reserve the right to cancel, change or suspend this event. This right is reserved whether the event is due to human or technical error. If a solution cannot be found to restore the integrity of the event, we reserve the right to select successful entrants from among all eligible entries received before we had to cancel, change or suspend the Competition. If you attempt to compromise the integrity or the legitimate operation of this Competition by hacking or by cheating or committing fraud in ANY way, we may seek damages from you to the fullest extent permitted by law. Further, we may ban you from participating in any of our future Competition, so please play fairly.

#### **8. Data Protection**

Goodwood shall use and take care of any personal information you supply to it as described in its privacy policy, a copy of which can be seen at <https://www.goodwood.com/terms-and-conditions/privacy-policy/> and in accordance with data protection legislation. By entering the Competition, you agree to the collection, retention, usage and distribution of your personal information in order to process and contact you about your Competition entry, for the purposes outlined in paragraph 5 above and any other purposes provided these are notified to you and for which you have given consent.

## **9. Changing these terms**

Goodwood reserves the right to cancel or amend the Competition, or the Terms and Conditions at any time without prior notice. Any changes will be posted within these Rules.

## **10. Liability**

Goodwood and the sponsor accept no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering the Competition or accepting the prize. Goodwood and the sponsor further disclaim liability for any injury or damage to your or any other person's computer relating to or resulting from participation in or downloading any materials in connection with the Competition. Nothing in these Terms and Conditions shall exclude the liability of Goodwood or the sponsor for death, personal injury, fraud or fraudulent misrepresentation as a result of its negligence.

## **Section Two**

The Terms and Conditions set out in this section apply to the Goodwood Road Racing Company Limited's #MastercardHotLaps Competition. Additional Terms and Conditions applicable to all competitions are included in Section One.

### **1. When will the Competition take place?**

#### **Open Qualification:**

The open qualification phase ("Open Qualification") is open for entries from 09:30 hours Greenwich Mean Time ("GMT") on 28 April 2021 until 23:59 hours GMT on 31 May 2021 the ("Open Qualification Hours").

#### **Heat Phase:**

The heat phase ("Heat Phase") will be held on two days being 6 June 2021 between 12:00 and 20:00 GMT and 13 June 2021 between 12:00 and 20:00 GMT.

#### **Final:**

The final race ("the Final") will be held on a day to be advised to entrants who qualify to the Heats Phase. The entrants who qualify and participate in the Heats Phase will be advised on the Final time and date no later than 48 hours after the first day of the Heats Phase being 6 June 2021.

### **2. How do I enter?**

#### **Open Qualification:**

You can enter by recording a video of your hot lap of the Goodwood Motor Circuit in the PlayStation Gran Turismo Sport Game from start to finish. Upload your video recording of your hot lap onto any of the following social media channels: Facebook, Twitter, or, Instagram. Your post will need to use the hashtag #MastercardHotLaps and include your hot lap time and your GT Sport gamertag in the post. You will need to have a Facebook, Twitter or Instagram account to take part and your post must be made in public mode. Any posts made in private mode will not be eligible and will be an invalid entry.

#### **Heat Phase:**

Entrants will be seeded into five (5) heat groups of ten (10) entrants in each heat group. Each entrant will have the opportunity to race in two (2) races against their heat group. The entrant's finishing position in the races will be ranked and points scored. The entrant's final heats stage score will be the cumulative points scored across the two races.

The same car is to be used by all entrants and Goodwood will specify the make and model.

**Final:**

The two (2) entrants with the highest scores in their heat group after the two heats races in the Heat Phase will progress to the Final. There will be ten (10) entrants in total who will be in the Final. The two (2) entrants whose scores rank them 11<sup>th</sup> and 12<sup>th</sup> will be offered the position of 'reserve' finalist. These entrants will be invited to participate in the final should one of the 10 finalists be unable to attend and will be requested to log-in for the Final as a standby finalist.

The same car is to be used by all entrants and Goodwood will specify the make and model.

**3. What are the prizes?**

There is one prize that will be awarded, consisting of the following:

- a) Two (2) general admission tickets for the Thursday of the Goodwood Festival of Speed 2022 presented by Mastercard;
- b) One (1) Rally Stage passenger experience in a vehicle chosen by Goodwood to take place on the Thursday of the Goodwood Festival of Speed 2022 presented by Mastercard;
- c) One (1) night stay at Goodwood Hotel for two people (double / shared occupancy room). The night stay at the Goodwood Hotel will take place on the Wednesday evening before Goodwood Festival of Speed 2022 presented by Mastercard;
- d) Drinks served next to a forest firepit on the Goodwood Estate for two people to take place on the Wednesday evening before Goodwood Festival of Speed 2022 presented by Mastercard;
- e) 'Ultimate Racing Bundle' including: PC, rig, wheel, pedals, screen, headset, keyboard, mouse. Goodwood retains the right to provide the bundle by any supplier and any model;
- f) Three (3) one hour one to one digital e-sports coaching sessions by Elite Williams Coach. These sessions will be virtual. Dates and times to be agreed by between Goodwood and the prize winner. To be redeemed no later than 1 July 2022.

If for any reason an advertised prize is unavailable, we reserve the right to substitute a prize of equal or greater value or postpone the fulfilment of the prize to a future Goodwood event.

**If you are selected as a potential winner:**

1. You may not exchange your prize for cash or any other merchandise or services.
2. You may not designate someone else as the winner. If you are unable or unwilling to accept your prize, we will award it to an alternate potential winner via the same method.
3. If you accept a prize, you will be responsible for all applicable taxes related to accepting the prize, if any.
