

## Terms and Conditions of the Goodwood Road Racing Club Fellowship

Any questions concerning these Terms and Conditions should be directed to the Goodwood Road Racing Club Team.

### Key terms and conditions:

- To become a Fellow or renew your Fellowship subscription, you request the GRRC to begin the supply of digital content to you during the 14 day cancellation period. You acknowledge and agree that you will not be entitled to receive a refund of your subscription payment once you have logged in to your account.
- When approved for Fellowship, the Fellow will be deemed to have agreed to be bound by these Terms and Conditions as they may be amended from time to time.
- A Fellow may only resign their Fellowship via the online cancellation form at [www.goodwood.com/fellowship](http://www.goodwood.com/fellowship), emailing [fellowship@goodwood.com](mailto:fellowship@goodwood.com) or in writing directly to the Goodwood Road Racing Club Team.
- In the event of resignation, suspension or termination of Fellowship during the year, the Fellow will not be entitled to a refund of the annual fee either in whole or in part.

### 1. Fellowship

1.1 Persons wishing to apply for Fellowship must complete an online Application for Fellowship form at [www.goodwood.com](http://www.goodwood.com).

1.2 The Goodwood Road Racing Club (“GRRC”) may decline any application to become a Fellow or for renewal of Fellowship and shall not be obliged to give any reason for doing so.

1.3 The number of Fellows at any time is decided by the GRRC.

1.4 Fellows shall be invited to renew their Fellowship annually through payment of the annual fee. The amount of this fee will be determined by the GRRC.

1.5 The violation of any of these Terms and Conditions or any conduct unbecoming or against the interests of the GRRC will subject the Fellow responsible to disciplinary action by the GRRC at their absolute discretion and may result in expulsion from Fellowship and refusal of any subsequent application for Fellowship.

1.6 Honorary Fellowship may be bestowed only by the Duke of Richmond.

### 2. Privileges

2.1 Fellowship enables all Fellows to benefit from Fellowship benefits. Full details of each year’s benefits of Fellowship can be obtained online at [www.goodwood.com/fellowship](http://www.goodwood.com/fellowship).

2.2 The GRRC reserves the right to vary or cease to provide each and any benefits and shall not be required to provide any alternative benefit(s).

2.3 The selling or transferral of Fellowship benefits or privileges such as merchandise discounts to third parties is strictly prohibited and will result in disciplinary action by the GRRC at its absolute discretion and may result in expulsion from Fellowship and refusal of any subsequent application for Fellowship.

### 3. Rights and Obligations

3.1 The Fellowship year for each Fellow will constitute the twelve month period commencing on the date of joining.

3.2 Dues are payable in advance and the annual fee is due at the start of each Fellowship year for each Fellow. Payment will be taken automatically from the payment card supplied on joining the Fellowship unless the Fellow notifies the Goodwood Road Racing Club Team via the online cancellation form or in writing not less than two weeks before the payment is due that he or she no longer wishes to be a Fellow.

3.3 If a Fellow's payment card expires or is replaced before a renewal date, it is the Fellow's responsibility to notify the Goodwood Road Racing Club Team of the new payment card details to ensure the Fellowship continues and if applicable the Fellow's status as a GRRC Member-in-Waiting is maintained in the correct order.

3.4 Failure to pay the required dues within the time specified by the GRRC for renewal of Fellowship shall constitute grounds for forfeiture of Fellowship privileges and may constitute grounds for termination of Fellowship and if applicable removal of the Fellow's Member-in-Waiting status, at the discretion of the GRRC.

3.5 If a Fellow opts in to become a Member-in-Waiting, they will be assigned a Member-in-Waiting number which corresponds to the order at which Fellows will be invited to join the GRRC Membership. The number of Fellows invited to become GRRC Members each year is at the discretion of the GRRC. Once invited to become a GRRC Member, a Fellow can accept the invitation and join as a GRRC Member, or can decline and decide to remain a Fellow or to cancel their Fellowship as per section 3.2. Upon remaining a Fellow or cancelling their Fellowship, the Fellow will lose their position within the order as a Member-in-Waiting, but is entitled to re-join the Member-in-Waiting line by re-starting the process.

#### **4. Data Protection and Compliance**

4.1 In accordance with the Data Protection Act 2018, each company in the Goodwood group (The Goodwood Estate Company Limited and each of its subsidiaries) (the 'Company') is registered with the United Kingdom's Information Commissioner's Office as a data controller to collect information. The Company only gathers personal information, such as first and last names, contact details, addresses and email addresses. This information is collected to help the Company manage the Fellowship. The Company also reserves the right to use or disclose any information as needed to satisfy any law, regulation or legal request, to fulfil the requests of Fellows, to provide Fellows with information or to cooperate in any law enforcement or regulatory investigation. Such communications will be provided to Fellows by email, post or by telephone. All personal information that the Company collects about its Fellows will be recorded, used, and protected by the Company in accordance with applicable data protection legislation. The Company's privacy policy can be found at <https://www.goodwood.com/terms-and-conditions/privacy-policy/>, which sets out the Company's general and overarching policy regarding privacy and data. The Company will not transfer personal data outside of the European Economic Area and the Company will only retain personal data for as long as necessary to fulfil the purposes it is collected including for the purposes of satisfying any legal requirements. A Fellow has the right to ask the Company to provide he or she with all the information it stores on them and to ask the Company to rectify, block, complete and delete such personal data or to restrict its use.

4.2 The GRRC has put in place procedures to prevent any employees, agents or subcontractors from engaging in any conduct that would constitute an offence under the Bribery Act 2010 or which would result in liability for fraud, insolvency crimes or other corruption crimes. The GRRC requires any person who is involved in any way with it, whether as an officer, employee, Fellow or guest or other associated person not to undertake any conduct which would or could constitute such an offence. Appropriate steps will be taken in relation to any person found to be in breach of this obligation. In the case of a Fellow, this will result in immediate termination of Fellowship.

#### **5. Disputes**

The GRRC and the Fellows should always seek to resolve any disagreements in a friendly manner and in good faith. In the absence of an amicable settlement, any dispute will be judged exclusively by the courts of England.

GRRC reserves the right to change these Terms and Conditions from time to time.
