

Terms and Conditions Applicable to the SpeedWeek Mastercard Predictor competition

The terms and conditions set out in Section One apply to all of the competitions operated by the Goodwood Road Racing Company Limited ("Goodwood"), whose registered office is at Goodwood, Chichester, West Sussex PO18 0PX, company number 466176. You can contact Goodwood at this address.

Additional Terms and Conditions for each individual competition are included in Section Two.

The terms and conditions set out in Section One and Section Two are referred to as the "Rules" and this promotion will be simply referred to as the "Competition" throughout the rest of these Rules.

In these rules, "we," "our," and "us" refer to Goodwood and "you" and "yourself" refers to an eligible Competition entrant.

Section One

1. Who is promoting/sponsoring this Competition?

The promoter of this competition is Goodwood. The sponsor of this competition is Mastercard Europe Services Ltd.

2. Can I enter?

You are eligible to enter this competition if you meet the following requirements:

If you are a potential winner, we will notify you by either a phone call or email used at time of entry within fourteen (14) days following the competition closing. If our attempts to contact you is returned as undeliverable, or we are unable to reach you for any reason, we may randomly select an alternate winner.

If you are a potential winner, we may require you to sign a declaration of eligibility and liability/publicity release before the prize can be fulfilled. If you do not sign and return these required forms within the time period stated, we may disqualify you and select an alternative winner.
