Terms and Conditions applicable to Goodwood Motor Circuit, Race Simulator Competition

The terms and conditions set out in Section One apply to all of the competitions operated by the Goodwood Road Racing Company Limited ("Goodwood"), whose registered office is at Goodwood, Chichester, West Sussex PO18 0PX, company number 466176. You can contact Goodwood at this address.

Additional Terms and Conditions for each individual competition are included in Section Two. The terms and conditions set out in Section One and Section Two are referred to as the "Rules". In these rules, "we," "our," and "us" refer to Goodwood and "you" and "yourself" refers to an eligible competition entrant.

Section One

1. Who is promoting competition?

2. Can I enter?

You are eligible to enter this competition if you meet the following requirements:

- You are 14 years or older at the time of entry, and
- You have taken part in the Goodwood Race Simulator Experience at Goodwood Motor Circuit, and
- You are not involved in any part of the administration and execution of this competition.

3. Rules about entry

Multiple entries are allowed; however, an individual can only submit one lap time per session booked and can only win a Performance Track Experience once in the previous seven-month period. If the person with the quickest lap has already won in the previous seven-month period then it will automatically go to the second quickest lap, and so on. The competition is only applicable to customers who have booked a slot or are redeeming a voucher for the race simulator at Goodwood Motor Circuit. The lap must be completed in the chosen car around the Goodwood Motor Circuit. Competition entries must be made in the manner and during the period specified in Section Two. Failure to do so will disqualify the entry. We reserve the right to disqualify any entrant if we have reasonable grounds to believe the entrant has breached any of these Rules.

4. How are winners selected and notified?

The following method of selecting the winners may be used in this competition. The method to be used is stated in Section Two. Within two weeks of the Closing Date specified in Section Two we, or a company acting under our authorization, in the presence of an independent adjudicator, will select the person who holds the quickest lap time, who hasn't won previously, and will be contacted by a member of the Goodwood Motor Circuit team.

If you are a potential winner, we may require you to sign a declaration of eligibility and liability/publicity release before the prize can be fulfilled. If you do not sign and return these required forms within the time period stated on the winner notification message, we may disqualify you and select an alternative winner.

5. Rules about prizes

There is no cash alternative. We reserve the right to substitute prizes of equal or greater value at any time. Prizes are awarded at our discretion and no prizes will be awarded as a result of improper actions by or on behalf of any entrant.

6. What other conditions am I agreeing to by entering this competition?

Section Two

Terms and Conditions applicable to Goodwood Motor Circuit, Race Simulator Competition

The terms and conditions set out in this section apply to all participants who enter the competition, launched on 10 June 2023 (the "Launch Date"). Additional terms and conditions applicable to all competitions are included in Section One.

1. When will the competition take place?

The competition is open for entries from the Launch Date at 08:30hrs until 23:59hrs (London time) on 30 April 2024 (the "Closing Date") and the period between the Opening Date and the Closing Date are the "Competition Hours". There will be a draw that will take place from the first day of each calendar month, running until the last day of each calendar month.

2. How do I enter?

By adding your lap time to the Goodwood Motor Circuit Leader Board which is located in the Simulator Suite. This will be done by the instructor on the day.

3. Selection of the winners

Each winner will be the participant who has the fasted lap for that month. If the participant who has the fasted lap has already won once in the previous seven-month period then the person with the second fasted lap shall be selected and so on. 4. What are the prizes?
