

TERMS AND CONDITIONS APPLICABLE TO THE GOODWOOD FESTIVAL OF SPEED “WIN FAMILY TICKETS TO FESTIVAL OF SPEED 2018, DISNEY PIXAR CARS 3 DVD, TOYS AND GAMES” COMPETITION

1. WHO IS PROMOTING/SPONSORING THIS COMPETITION?

2. CAN I ENTER?

You are eligible to enter this competition if you meet the following requirements:

4. HOW ARE WINNERS SELECTED AND NOTIFIED?
